NATIONAL PARKS AND WILDLIFE ACT 1974, section 91K(3)

NOTICE OF VARIATION OF DIRECTION FOR REMEDIAL WORK

Under section 91K(3) of the National Parks and Wildlife Act 1974 ("the Act"), I, Alistair Henchman, Director Parks and Wildlife Group Metropolitan Branch, Office of Environment and Heritage, Department of Premier and Cabinet ("the Department"), having delegated authority from the Director-General of the Department, vary the direction for remedial work made under section 91K(1) of the Act, dated 8 June 2011, Reference Number DOC11/26726, and applying to the land Lot 2 of Deposited Plan number 1151473 as follows:

- In Direction 1.1 of the Direction to Carry out Remedial Works, the words "On or before 18 July 2011" are deleted and replaced with the words "On or before 25 July 2011".
- In Direction 5.1 of the Direction to Carry out Remedial Works, the words "In the period 25 May 2011 to 30 September 2011" are deleted and replaced with the words "In the period 25 May 2011 to 31 August 2011".
- 3. In Attachment 8 of the Direction to Carry out Remedial Works, the whole of Table 2 is deleted and replaced with the following:
